A minimum deposit of \$500.00 is required per hunter and due with the contract. Before January 30<sup>th</sup>. Payments can be made by check or money order.

Cancellation Policy: Any Payments made are not refundable but can be transferred to the following year or another person to replace you.

Licenses, tags, taxes, gate fees and gratuities are not included in the hunt prices unless specified.

Hunters agree to abide by all Maine fish and game laws while staying with Allagash Wilderness Camps. We have a zero tolerance policy for game violations.

Hunters should be proficient with their weapons of choice, be sure to practice with your weapon prior to arrival at Allagash Wilderness Camps. You should also bring extra ammo or arrows and broad heads for practice when you arrive here.
